History

Region V Title I Parents began under the leadership of The National Coalition of ESEA Title I Parents which was organized in 1973 by 50 parents to help parents become actively involved in the education of their children;

After the National was decommissioned to be reorganized, (which will be completed by the end of 2014) and during the reorganizing of the National, Region V Title I Parents stayed afloat and continued to educate parents to be partners with their schools and districts.

Title I of the Elementary and Secondary Education Act (ESEA) of 1965 and its' amendment of No Child Left Behind Section 1118 Parental Involvement;(e) Capacity building provided a may clause for parents to establish Parent Advisory Councils to help close the achievement gap between high- and low-performing children, especially the achievement gaps between minority and nonminority students, and between disadvantaged children and their more advantaged peer's. The PACs are to offer training programs for parents, as well as other members of the community who wish to bring about closing the gap in the context of a cooperative, non-threatening educational environment, this is the number one training agenda for Region V Title I Parents organization.

Service

Region V Title I Parents provides information, training, and technical assistance to parents, school districts and community organizations. The organization sponsors In-service and Professional Development Training Conferences and Seminars. Region V Conferences are the only regional Title I educational conference designed by parents, to bring together parents, teachers, students, federal/local program administrators, educators and community representatives to exchange information on ways to maximize educational opportunities for educationally disadvantaged children.
